CONDITIONS OF PARTICIPATION

1. Registration

The registration form should be fully completed and sent as soon as possible to secure a place. If the excursion for the given date is already fully booked or does not have enough registrations, the registrant will be notified immediately and redirected to a similar excursion at a later date.

2. Confirmation of successful registration and participation fee

If the excursion is to take place on the given date due to a sufficient number of registrations, each registrant will receive a confirmation of successful registration within one week after the registration deadline, which will be accompanied by an invoice for the participation fee. The participation fee is due upon receipt of the invoice, but no later than 30 days afterwards.

3. Age

Participant must be at least 18 years old at the begin of excursion.

4. Health and safety

Participants are responsible for their own health suitability and should be in good physical condition and have no health restrictions that could jeopardize their participation. Please wear appropriate clothing and sturdy footwear to avoid injuries.

5. Equipments

Each participant is responsible for their own equipment. Recommended gear includes – among others – sturdy footwear, weather-appropriate clothing, sun protection.

6. Responsibility

Participants are at their own risk. The organizer accepts no liability for injuries or damages that occur during the excursion. It is recommended to take out an overseas accident and health insurance/travel cancellation insurance before the trip.

7. Conduct

Entering restricted or dangerous areas in quarries or mines is prohibited. As the paths to the mines can change due to variable weather conditions and mining activities, there may be last-minute changes in the daily excursion schedule. All participants agree to follow the instructions of the excursion leaders.

8. Cancellations

Cancellation of the excursion in case of inability to attend must be communicated to the excursion organizer immediately. The following regulations apply to the due date of participation fees: **a)** For cancellations made within 30 days after the confirmation of acceptance, the participation fee is not due. Already paid participation fees will be fully refunded; **b)** For cancellations made 30 days to 8 weeks after the confirmation of acceptance, 25% of the participation fee will be retained as processing and administration costs; **c)** For cancellations made up to 12 weeks after the confirmation of acceptance, 50% of the participation fee will be retained as processing and administration costs; **d)** In case of cancellations later than 12 weeks after the confirmation of admission, as well as in case of no-shows at the beginning of the excursion, the participation fee will not be refunded. In the regulation according to d), we must assume that the vacant excursion spot cannot be filled again due to the short notice, whereby the special reasons of the withdrawing or absent registrant cannot be considered.

9. Miscellaneous

The organizer reserves the right to make changes to the program if this is necessary for organizational reasons. In case of bad weather or force majeure, the excursion may be postponed or canceled. If the excursion has to be canceled by the organizer in that sense, already paid fees will be refunded.
